Agreement Details

The Wisconsin FFA Foundation's Star Mission Partner Program is designed to provide optimum recognition for your support of the Wisconsin FFA. A short list of guidelines outlining program expectation has been developed to help deliver meaningful results for your investment in the program.

1. Once your commitment form is received and processed, you will be sent a confirmation of your participation as a Wisconsin FFA Foundation Star Mission Partner.
2. All new Star Mission Partner agreements will be activated at two points of the year:
 - Agreements received between Dec 1 and April 30 will be activated June 1.
 - Agreements received between May 1 and Nov 30 will be activated Jan 1.
3. The partnership payment(s) can be submitted as one sum or incrementally. All funds must be received prior to the respective activation date (see bullets above).
4. Biannual updates will be sent to review the recognition provided, announce any changes to the program and inform you of the efforts supported through the partnership.
5. When the agreement end date is approaching notification will be sent to invite you to renew the commitment.
6. The Wisconsin FFA Foundation is a nonprofit organization and contributions are tax-deductible.
7. Recognition of our donors by the Wisconsin FFA Foundation does not constitute an endorsement of the products or services of the partnering company, organization or individual.
8. Funds received through the Wisconsin FFA Foundation's Star Mission Partner Program will be used to underwrite any and all costs associated with carrying out the mission of Wisconsin Agricultural Education and FFA to the highest level of quality possible. One-tenth of the proceeds will be distributed to each of the five participating organizations (Wisconsin FFA Alumni, Wisconsin FFA Center, Wisconsin Association of FFA, Wisconsin Association of Agricultural Educators and Wisconsin FFA Foundation). The other half will be available for the groups to access through a grant program in order to fund mission-based initiatives.
